Sean Cairncross formerly served as the Deputy Executive Director and General Counsel to the National Republican Senatorial Committee. Cairncross served in this role at the NRSC for two cycles (2009-2012) under Senator John Cornyn (R-TX), overseeing the NRSC's day-to-day operations and legal matters, and during which time Republicans picked up 5 seats in the U.S. Senate. Sean previously served as Chief Counsel to the Republican National Committee, where he oversaw the RNC's legal operations including its interactions with the **McCain campaign**. Cairncross joined the RNC in 2004, and served two and a half cycles under Chairmen Gillespie, Mehlman, and Duncan. Before that Cairncross worked as a litigation associate at the Washington D.C. offices of **Covington & Burling**.

Sean holds a J. D. from NYU School of Law, an M.Phil from Cambridge University, and a B.A., summa cum laude, from American University. Originally from Minnesota, he currently lives in Washington, D.C., and is a member of the District of Columbia Bar.

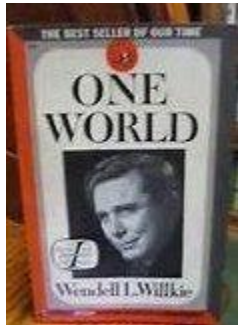

The **Willkie nomination**, one of many **successful covert operations** masterminded by this troika, was carried out through the joint efforts of **British intelligence** and its fledgling American counterpart, what would become the **Office of Strategic Services (OSS)** and, later, the **Central Intelligence Agency (CIA)**. Key high-level operatives in this intelligence operation were Sam Pryor, Oren Root, **Thomas Lamont**, media magnate **Henry Luce**, **Willkie's campaign manager** (and Luce's managing editor at *Fortune* magazine) **Russell Davenport**, (skull & bones) and British Ambassador **Lord Lothian**.

Lord Lothian enjoyed a good relationship with senior figures in the press world such as **Arthur Hays Sulzberger** NY Times, **Walter Lippmann** and **Helen Ogden Reid**.

Lothian explained to the Chicago branch of the **Council on Foreign Relations** in January 1940: "Propaganda is the deliberate attempt to influence your countrymen or other nations to a particular course of action, by lies or half truths or tendentious innuendos. The truth is never propaganda; it is the staff of life."

Winston Churchill blamed **Lord Lothian** (Phillip H. Kerr) for persuading Lloyd George to reject his scheme for larger-scale allied intervention against the **Bolsheviks** during the **Russian Civil War**.

Walter Lippmann said that mass man functioned as a "bewildered herd" who must be governed by "a specialized class whose interests reach beyond the locality. **Lippmann** was commissioned a captain in the Army and was assigned to the intelligence section of the AEF. **Lippmann** was assigned to the staff of Colonel **Edward M. House**.

House was a founder of the **CFR** and wrote the book **Phillip Dru Administrator** proposing a coup and an American dictatorship including a North American Union.

Skull & bones masterminded **Willkie's campaign** with British intelligence ...specifically with the man Churchill claims saved the **Communist Bolsheviks** ... **Lord Lothian**.

KSCO's radio host calls himself a **Wendell Willkie Republican** **Charlie Freedman**. Of course propagandist **Freedman** never mentions CFR/T/B/S&B) and hangs up on those who do.

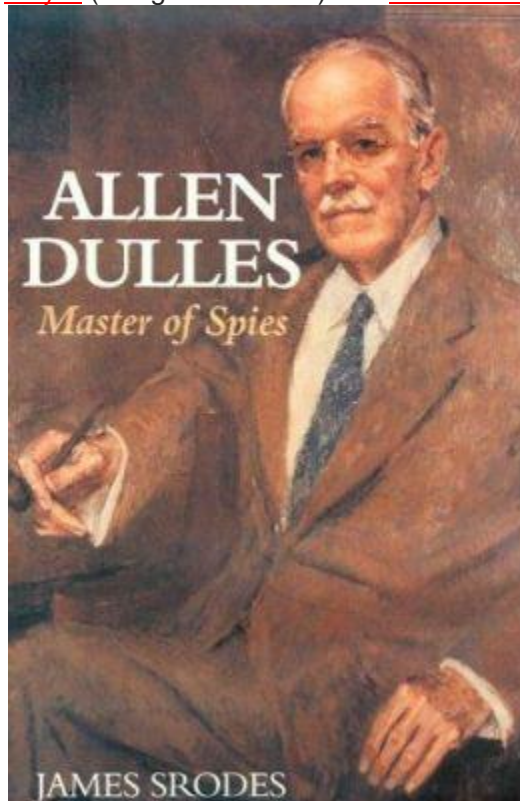
Claire Luce was awarded **Dames of Malta** ... the female half of the **Knights of Malta**.

Clare Luce was big on immigration wanting to get rid of the Chinese Exclusion Act and co-authored the **Luce-Celler Act** of 1946. **Congressman Celler** made his first important speech on the House floor during consideration of the Johnson Immigration Act of 1924 to destroy Congress's imposed quota that limited immigration for persons of any nationality to 3 percent of that nationality present in the United States in 1910, with an annual admission limit of 356,000 immigrants.

Open borders is important for the construction skull & bones **New World Order**. But like **Bernie Sanders** he verbally opposed monopoly mergers.

It is well-known that **Henry Luce**, (skull & bones) as a key figure in **Operation Mockingbird**, played an important role in the cover-up in the assassination of JFK. 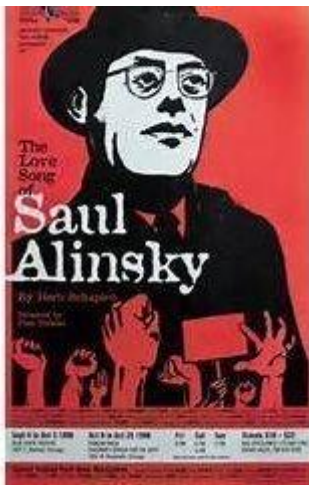
Operation Mockingbird was a secret campaign by the United States Central Intelligence Agency (CIA) to influence media. Begun in the 1950s, it was initially organized by Cord Meyer (Reagan's handler) and Allen W. Dulles (a founder of the CFR).



According to **The Secret History of British Intelligence** in the Americas, 1940-45, a secret report written by leading operatives of the British Security Coordination (Roald Dahl, H. Montgomery Hyde, Giles Playfair, Gilbert Highet and Tom Hill), William Stephenson and BSC played an important role in the **Council for Democracy**, a group established by **Luce** and his wife **Clare Boothe Luce**.

The Irregulars: Roald Dahl and the British Spy Ring in Wartime Washington (2008) argues that **Ernest Cuneo** was "empowered to feed select British intelligence items to friendly journalists such as Walter Winchell, Drew Pearson, **Walter Lippman**, **Edward Murrow**, Vincent Sheean, Eric Sevareid, Rex Stout, who "were stealth operatives in their campaign against Britain's enemies in America".

Cuneo also worked closely with editors and publishers who were supporters of American intervention into the Second World War. This included **Henry Luce** (Life and Time), **Arthur Hays Sulzberger** (New York Times), Helen Rogers Reid (New York Herald Tribune), Paul C. Patterson (Baltimore Sun), **Marshall Field III** (Chicago Sun) **Marshall Field III** (September 28, 1893 – November 8, 1956) was an [American investment banker](#), (Morgan), heir to the [Marshall Field department store](#) fortune and a leading financial supporter and [founding board member of Saul Alinsky's community organizing network Industrial Areas Foundation](#).

Kate Obenshain husband **Richard** is the son **Samuel Obenshain** of The **Byrd Organization** (usually known as just "the Organization") was a [political machine](#) led by former Governor and U.S. Senator [Harry F. Byrd, Sr.](#) (1887–1966) that dominated [Virginia politics](#).

Richard did help end Virginia as single party state by strengthening the [Republican Party](#) there.

Claire Luce is "family" and was an actress and dancer.

Frank Donatelli was assistant to **James Baker** (Woodrow Wilson Award, tennis partner to **George H. W. Bush** (skull & bones)

In 1982, conservative activists **Howard Phillips**, founder of **The Conservative Caucus**, and [Clymer Wright](#) of Houston joined in an unsuccessful effort to convince **Reagan** to dismiss **James Baker** as

Chief of Staff. They claimed that Baker, a former Democrat and a Bush political intimate, was undermining conservative initiatives in the administration.

In mid-2002 the **Council on Foreign Relations (CFR)**, together with the **James A. Baker III Institute for Public Policy**, established a 23 member planning group to formulate the U.S. war aims. **James Baker III Institute for Public Policy** included nine staffers from the **CFR**.
